BEF PARA DRESSAGE TRAINING PROGRAMME CRITERIA

The criterion to be eligible to apply to ride on these days is:

- Be between 12 & 18 years old.
- Hold a National classification within the 4 Grades eligible to compete in British Dressage Para Equestrian competition *
- Be currently scoring 60% or above in their relevant grade at RDA qualifiers for the RDA National Championships.

***Riders with Learning Disabilities:**

Currently under Federation Equestre Internationale (FEI) rules, a rider with intellectual disabilities, who does not have a physical classification, is covered under Profile 39 of the Classification Guide (applicable to Grade III). This profile remains inactive at present so riders in Profile 39 are currently not eligible to compete in Para Equestrian competition run under BD & FEI rules. This policy will reviewed in line with any future decisions made by the F.E.I.
